### Congressman Franklin:

As I've said before, you need to cut https://ContractWithAmerica2.com/#pork spending, and that you did not do, nor did you even try. Do you disagree with my logic? If yes, please clarify. If no, then introduce one version of the bill outline in this section, linked above, SECTION II. Cutting pork spending. A copy of the needed bill is also in APPENDIX-A of the attached written testimony to the Senate Judiciary committee.

If you do not cut pork spending, then the very inflation which you decry (in your Facebook post) will continue and crash both:

- 1) the dollar and
- 2) the vulnerable power and telecom grid (because of lack of funding, see 1 above), as well as possibly,
- 3) electoral hopes of GOP candidates, such as you. Your new communications aid, retired LPD Sgt. James Ring , was good enough to give me the ok to ask him to listen to me. That's all good and well, and later tonight or tomorrow, I should hope to stop being lazy and nonproductive, and send you a complete "game plan" to avert disaster. But, whether I am responsible or lazy, the fact remains: If you continue the "lame, halfway" measures of lawmakers of both political parties, you absolutely WILL allow this "bad" inflation to crash the dollar and the grid (due to funding needs) and the nation. Do not expect a miracle. Do expect a crash of the dollar (and the grid due to inadequate upgrade funds) if you don't listen to sense and file or cosponsor the bills in question. Caveat: I have not spoken with Dr. Pry regarding my theory that S.2598 is needed to force down pork spending and make it possible to fund needed upgrades to the GRID, so please don't construe my dropping his name as such. Nonetheless, while I would hope and guess he might agree here, the fact remains, I am your Constituent and am speaking in official capacity because I seek your legislative representation to avert disaster on several levels.
