GRIMSLEY PLAINTIFFS' NOTICE OF CORRECTED FILING TO FIX SCRIVENERS' ERROR IN THEIR RESPONSE TO DEFENDANT WASHINGTON COUNTY CLERK'S EMERGENCY MOTION FOR CLARIFICATION

The *Grimsley* Plaintiffs ("Plaintiffs") wish to advise the Court of a scriveners' error they discovered in their response to Defendant Washington County Clerk's Emergency Motion for Clarification, filed on December 29, 2014 (*Brenner* Doc. 105).

On page 3 of that filing, Plaintiffs stated: "Section 741.04(1) provides that *clerks and county court judges* may not issue marriage licenses to **different**-sex couples; it says nothing about the duties of any state agencies with respect to the restriction of marriage to different-sex couples." *Brenner* Doc. 105 at 3 (bold emphasis added). The sentence should have stated: "Section 741.04(1) provides that *clerks and county court judges* may not issue marriage licenses to <u>same</u>-sex couples; it says nothing about the duties of any state agencies with respect to the restriction of marriage to different-sex couples."

Plaintiffs realize that their inadvertent mis-description of the statute could inadvertently mislead. A corrected page 3, substituting the proper word, is attached as an exhibit hereto.
