Title: AskThePreacherFri04Dec2020 & Fri21June2013 (Infant Soteriology & Speaking in Tongues) WLKF Lakeland

ASK THE PREACHER call in show (WLKF Talk 1430 AM, 96.7 FM) Double Header, 5pm-6pm FRIDAYS:

Part 1: Fri 04 Dec 2020, Pastor Jon Friedt (BELIEVER'S FELLOWSHIP, Lakeland, Fla), I ask the age-old infant soteriology question about whether deceased babies go to heaven, but with a twist: Since UNIVERSALISM (all people of any group go to heaven WITHOUT exercising faith in Jesus) is false, and since the Millenium (Rev. 20:4) -- while not mandatory as an option -- is DEFINITELY Biblically permitted, then what's Pastor Jon think of my theory that babies who didn't get a chance to exercise faith on earth will get a chance in the Millenium? Not a 2nd chance, as they didn't get a 1st chance, and not unprecedented, as both angels (IN HEAVEN) and humans (here) get free will. While Pastor Jon was caught off guard, he nonetheless did not cave in to support the Biblically prohibited UNIVERSALISM Heresy, and thus is noted as a Scriptural and Biblically accurate preacher who understands Scriptural hermeneutics and exegesis, namely when considering an impossible and prohibited theory versus a possible one, don't rule out the possible or cling to the impossible: only THREE things exist in the world-- The Biblically MANDATED, the Biblically IMPOSSIBLE, and those things that -- while aren't mandatory, are non not prohibited, as is the case here.

Part 2 is a repeat and reprise of an old Friday, 21 June 2013 program with Pastor Wayne Friedt, Jonathan's father, who took my question on speaking in tongues. Key, however, is that while my call in wasn't specifically about infant soteriology (the means by which infants can be saved), nonetheless, I alluded to a cop of my book which i had given Pastor Wayne Friedt, and -- like his son -- he is a solid Bible teacher who, while not saying that my theories are required and mandatory, nonetheless, is an honest theologian who has Scriptural exegesis and uses Biblically supported hermeneutics to accept that my theories (Rev. 20:4 Millennium and Rev. 20:5 Rest of the Dead) are possible with regard to time/place of an opportunity for infants -- like angels & adults -- to exercise Free Will to believe or reject Sovereign King Jesus as Saviour.
