**Court and Counsel:**

The Illinois Supreme Court has just docketed my motion to reconsider a denial of my Rule 383, Supervisory Order Motion, along with an Amended Certificate of Service which the Clerk of the IL Supreme Court requested I submit. Additionally, I have filed Motions for Clarification and Extension of Time to file the Record on Appeal with the First Appellate Court in the above-captioned cases. These filings are a bit different than prior filings by any party, insofar as both serious Rule 11(a) violations, as well as documentation to the court, has been included. While my electronic service is not the proper venue to argue these points, I would be remiss in my duty to fail to mention it: If you are an attorney or party in these cases, the R.11(a) allegations may involve you, and you may want to take a closer look. At this time, the IARDC (Illinois Attorney Registration & Disciplinary Commission) has not been formally notified, but I have it on good authority that they are aware of these issues, and I can not speak for them as to whether they will overlook these violations of the Supreme Court Rules. Additionally, I apologize for slight delays in effecting service, but both courts returned my filings and requested minor *de minimus* corrections, and resubmission, thus delaying my filings, printing, & service by Postal Mail, email, etc. – My apologies. – **Additionally, a few weeks ago, I nearly lost my life, and am still not fully recovered, which may account for a slight delay in serving you copies (as documented in the medical records in my exhibits). Again, my apologies for the slight delay in complying with Rule 11(a) service requirements (which I've asked others to do in my filings to The Courts).**

As required by Rules 9-12, I filed electronically with the Supreme Court and the Appellate Court, and am effecting service as indicated in the Certificates of Service, and including courtesy email copies of those court and counsel for whom I have email addresses. The lead document is a 145-page PDF file, has 3 exhibits, two of the exhibits, themselves, having numerous exhibits (A-O), and is about 23.6 MB in file size, and is therefore too large to include as an attachment. **Pursuant to Rule 11(c), "If service is made by e-mail, the documents may be transmitted via attachment or by providing a link within the body of the e-mail that will allow the party to download the document through a reliable service provider."** You may pick up a copy at mirror 1, hosted by GoDaddy, in Mesa, AZ:
