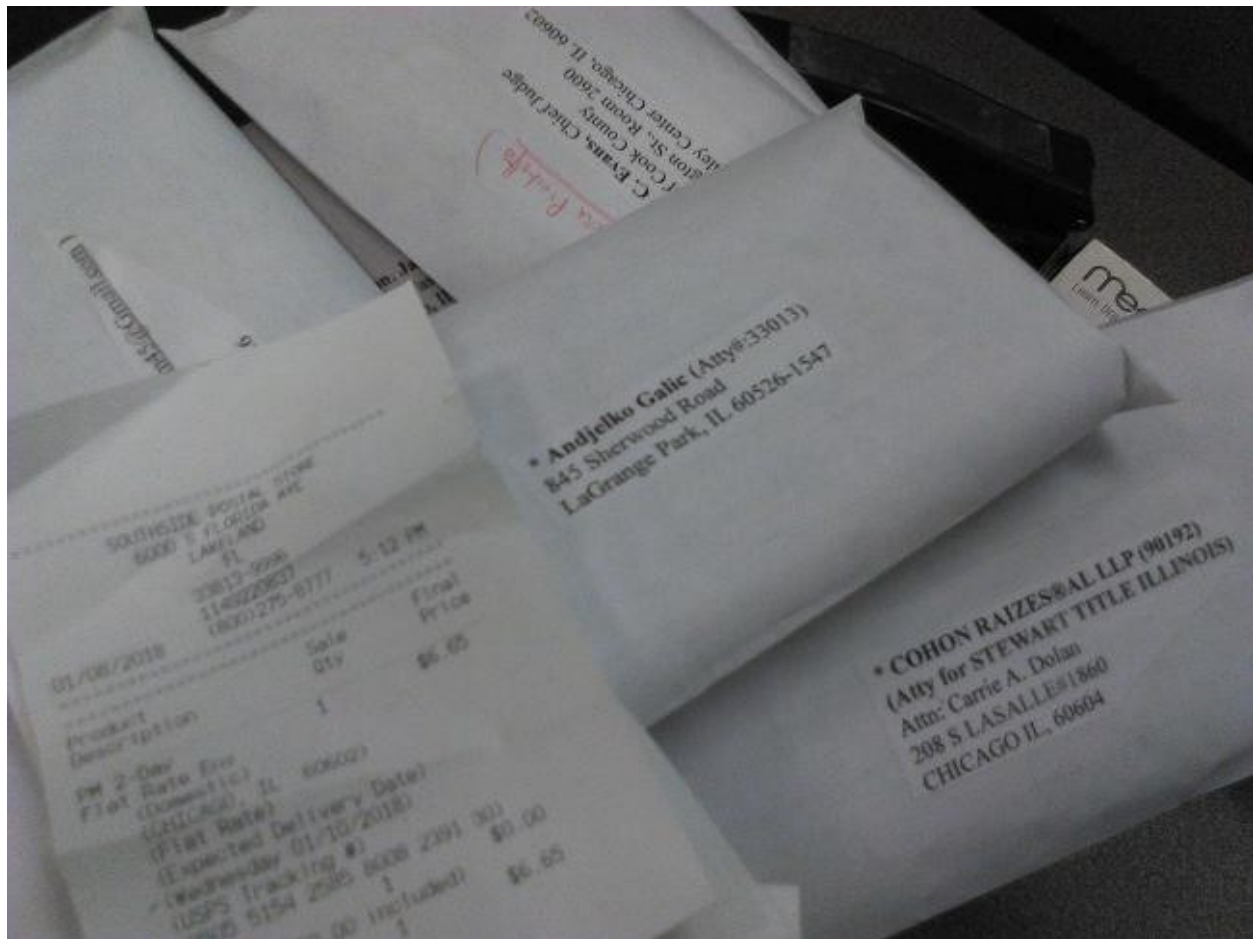


**** Exhibit 'K-4' -- Gordon Wayne Watts filing**

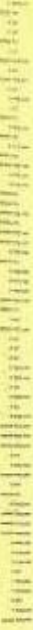
