Selected documentation that Atty. Joseph Younes, Esq., a Chicago, IL accident attorney, is not only a vexatious litigant, but also, possibly involved in blackmailing Stewart Title and/or US Bank with regard to "Linda Green" robo-signing Mortgage Fraud and/or failure to give "clear title" for 1720 N. Sedgewick St. (Old Town district), Chicago, IL 60614.

Explanation: The documentation regarding US Bank (and one other bank and 2 other loan servicers) is the complait that Younes submitted to the IL Atty. General's Office, in which he filed a complaint alleging that US Bank and friends were guilty of the aforementioned robo-signing fraud. (I.e., he admitted to knowledge of said fraud, but continued to participate in it, and benefited financially from it – GREATYLY – as evidenced by the "sweet" deal he got on a Loan Modification, which was very-recently recorded at the Cook County, IL Recorder of Deeds office. - 1) Younes' complaint to **Lisa Madigan** (IL Atty. General's Office) against US Bank & 3 others of robosigning fraud—wherein Younes ADMITS to said fraud, but as we all now know kept participating in and benefiting from said fraud.
- 2) The VERY recent "Loan Modification" agreement, wherein Younes gets a VERY "sweet deal" in his Loan Mod, as recorded at the <u>Cook County, IL Recorder of Deeds Office</u>. Again, I do not allege blackmail, but I DO SAY, in no uncertain terms, that this Loan Mod looks VERY suspicious, odd, and unexplainable otherwise.
