An accounting of what I got is as follows:

Lisa's 1st email: Ten (10) pages.

Lisa's 2nd email: Thirteen (13) pages.

Lisa's 3rd email: She included a duplicate, so only eighty-one (81) images were unique.

Lisa's 4th email had attachments which were identical to those of her second (2nd) email, above, and I should not be charged for duplicates.

Lisa's 5th & last email only had four (4) *.tif image attachments, but all of them were duplicates of attachments found in her 3rd email, above.

**Ten + Thirteen + Eighty-one
=equals= One-Hundred and Four (104) images that were not duplicates.**

An accounting of what I would owe is as follows:

**** Search fee: None – since I provided the case number and style of the case. (-: I thank them for not charging me this, since I would not previously know this had they not told me. Good job! I appreciate honest neighbours!! :-)**

**** First page: \$2.00**

**** Next nineteen (19) pages: 19 x (\$0.50) = \$9.50**

**** There were 104 pages, total, and 20 were accounted for above, so the remaining pages are 84 in total: 84 x (\$0.25) = \$21.00**

Costs incurred: \$2.00 + \$9.50 + \$21.00 = \$32.50

However, she charged me One-hundred and One dollars and seventy-five cents (\$101.75) for this (see below).

That would imply a 381-page Records Request: \$2.00 for first page, \$9.50 for next nineteen pages, and 361 more pages at \$0.25/each, adding another \$90.25, which would add up to \$101.75, as charged for this. I'm guessing it was an accident, but I was over-charged (see both images below, both what I was quoted, and a copy of my Credit Card receipt, which shows the charge, plus a small 2.1% service fee of \$2.14

Thus, I was over-charged \$69.25 –not counting the 2.1% service fee, the headache researching the details, and/or several days of near-continuous research from then (early AM on Fri. 08-11-2017) until now (late PM on Tue. 08-15-2017) of time lost from work researching and documenting this.

Alternatively, I paid for 381 pages, and got only 104, so, alternatively, I am owed 277 more pages, if I ended up needing more records.

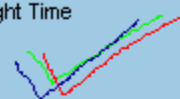
