**Dear Jake or Christine:**

With regards to the 3 PDF attachments, in this email here, which I have filed in the case so denoted in the style of the case, I may, *if I have time*, file a supplemental sworn & notarised affidavit of a few more things I have discovered, as a witness to this case. In addition to being friends with the defendant (thereby having knowledge of the case), I also have a good grasp of law, as documented by the 4-3 loss in one high profile case I litigated all by myself in the Fla. Supreme Court, and so cited & documented in the filings in question.

**CAVEAT:** My inclusion of these filings IS NOT a prohibited *ex parte* communication (since, of course, I've already filed them, as you can verify by looking at the docket and the case file), but I am including them as a professional courtesy, since having them in electronic form is convenient, as well as to reference my request here: The court relies on electronic research. Therefore, additional hard copies of cases are not needed, only correct citations, which I am doing here via PDF attachments. Opposing counsel has already been provided with copies, as indicated in the CERTIFICATE AND AFFIDAVIT OF DELIVERY (aka: Certificate of Service), and in many cases documented by signature delivery confirmation.

Moreover, when calling her number, (312) 603-7551, the message redirected me to 312-603-4811, which said her room proper was 2401. Lastly, when I called 312-603-5940, some unnamed clerk in Judge Flannery's office said that 1912 was the correct room. While I don't know if I need to serve both the Law Division Clerk and the Judge's Chambers, in the rare times I litigate, I strive to serve both - as a professional courtesy (and because sometimes mail gets lost). **QUESTION PROPER: What is the correct service address for Hon.
