PETITION FOR RULE TO SHOW CAUSE AGAINST JOHN LAROCQUE


Now comes the Counter-Plaintiff, RICHARD DANIGGELIS, through his attorney, Andjelko Galic, and moves this court of an order finding John P. Larocque in indirect civil contempt. In support of his petition Counter-Plaintiff, RICHARD DANIGGELIS, states as follows:

1. On January 4, 2016 a subpoena was issued to John Larocque requiring him to appear for a deposition at 134 N. LaSalle Street, Suite 1040 in Chicago, Illinois 60602. See attached Exhibit "A", a copy of subpoena issued to John Larocque
2. On January 12, 2016 John Larocque was served with this subpoena. See attached Exhibit "B".
3. John Larocque did not appear for his deposition testimony that was scheduled for January 29, 2016 as required by the subpoena and he failed to contact Counter-Plaintiff attorney's office to schedule his deposition at some other time.
4. The subpoena served on John Larocque contained specific language advising him that his "failure to respond to this subpoena will subject you to punishment for contempt of this court".

5. John LaRocque's failure to comply with subpoena was intentional and without any legal justification.

6. As a result of John LaRocque's refusal to comply with this subpoena Counter-Petitioner was forced to incur additional attorney's fees and expenses.

Wherefore, Counter- Petitioner, RICHARD DANIGGELIS, prays for an order issuing a rule to show cause against John LaRocque returnable at a date certain, requiring him to appeal in court and to explain why he should not be held in indirect civil contempt for his failure to appear for his January 29, 2016 deposition and ordering him to pay for legal fees incurred in having to bring this Petition for Rule to Show Cause.
